- 2. DETERMINE PROJECT
 - a. Shawna will assist County and will review Preliminary Damage Assessment (PDA) reports to determine best project for DR funds.
- 3. RESOLUTION
 - a. County will need to call a special meeting to approve resolution once project is known.
- 4. NOTICE OF INTENT Shawna will coordinate with Clay County News
 - a. Publish date to be determined upon approval of application resolution.
 - b. Shawna will submit the application 5 days after this notice is published.
- 5. APPLICATION FORMS
 - a. Shawna will prepare and provide to the Judge all necessary documents that require a signature as the application progresses.

Summary of Current Disaster Funding Opportunities and Requirements for TxCDBG 03/04/2015

Requirements for both Disaster Relief Fund and Urgent Need Fund

- An application must be submitted by a City or County, which may need to work with one or more utilities to identify water and sewer infrastructure damage.
- The applicant must demonstrate that adequate local funds are not available, i.e., the applicant has less than six months of unencumbered general operations funds available or funds from other state or federal sources are not available to completely address the problem.

Disaster Relief Fund Requirements

- Maximum award of \$350,000 per applicant per event.
- Requires the Governor to proclaim a state disaster declaration or the President to issue a federal disaster declaration.
- Priority is for repair and restoration activities to meet basic human needs, such as water and sewer facilities, housing, and roads.

Urgent Need Fund Requirements

- Maximum award of \$250,000 per applicant per event.
- Must provide matching funds equal to 20 percent of the TxCDBG funds requested.
- Funds activities that will restore <u>water or sewer infrastructure</u> whose sudden failure has resulted in death, illness, injury, or pose an imminent threat to life or health.
- Must provide a written request for Urgent Need assistance no more than 30 days after the situation first occurred
 or was first discovered, and must begin construction within 90 days of the start date of the TxCDBG contract.
- Must NOT be used for temporary solutions or back-up or redundant systems.

Process to receive FEMA Assistance:

- 1. County Judge sends a letter to the Governor's Office requesting assistance from TDEM.
- 2. TDEM assessment teams visit sites and document the damage, including affected cities.
- 3. A State-wide Presidential declaration occurs when state-wide damage per capita is \$1.30 or more.
- 4. FEMA provides Public Assistance funding if the county's damage per capita is \$3.27 or more.
- 5. County applies to FEMA based on the declaration and the damage assessments provided by TDEM.
- County provides matching funds of \$1 for every \$3 in FEMA funds; funds may be provided locally or the County may apply for TxCDBG Disaster Relief Fund.

Drought-Related Project Must Haves:

- An application must be submitted by a City or County, which may need to work with one or more water entities to identify water-related needs or damage.
- The applicant must demonstrate that adequate local funds are not available, i.e., the applicant has less than six
 months of unencumbered general operations funds available or funds from other state or federal sources are not
 available to completely address the problem.
- Maximum award of \$350,000 per applicant per event per beneficiary pool.
- The Governor's proclamation regarding the drought disaster... already given...is always prerequisite to receiving Disaster Relief funding related to drought assistance.
- Only under drought declaration can new infrastructure be installed.
- Applicant must provide evidence that 180 days or less water supply exists using the corroborative list maintained by TCEQ.
- The proposed project must offer a permanent solution.
