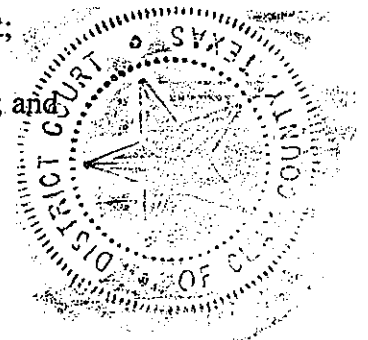

The Court finds that said applications should be granted, and


