

**Contract for Use of County-Owned Election Equipment
March 6, 2018 Primary Election(s)**

This contract for election services made by and between the Clay County Republican Party, hereinafter called "party", and Kenneth Liggett, on behalf of the Clay County Commissioners' Court, hereinafter called "county", and is based on the following:

The party and county have determined that the following contract be made and entered into for the purpose of having the county rent to the party, certain election equipment needed to legally conduct the March 6, 2018 Primary Election.

Election equipment to be rented:

- Sixteen (16) ES&S DS200 precinct scanners
- Sixteen (16) ES&S ExpressVote ballot marking devices

The party agrees to pay all programming fees, ballot costs, and election supplies fees directly to vendor, Election Systems & Software (ES&S). The party will be responsible for any election site support and/or training from ES&S. The Clay County Commissioners' Court has set a rental rate of \$5.00 per election machine and a delivery/pick up fee of \$200.00 per location.

**** Rental and delivery fees will be split and shared between Republican and Democratic Parties***

The party agrees to pay Clay County, c/o County Clerk, PO Box 548, Henrietta, Texas, the rental and delivery/pick up fees within FIFTEEN days of Election Day, in which the election was held, and the equipment was used.

If payment is not received within fifteen days, contracting officer may seek assistance in collections from District and/or County Attorney.
