- In the past few years, I have had problems with my feet, which is very hard for me to walk long distances.
- For the last few years, I have had to rely on a motorized scooter, to help me maneuver through the TLA conference.
- One time I did not use the scooter for two hours of walking at the conference, which resulted in a lot of pain and I had to take prescription medication.
- Last year, I also utilized the motorized scooter for the conference, in which the county paid the scooter rental, utilizing the schooling and travel funds.
- Gina called me and informed me, that I would have to ask for your approval to pay for the rental of the motorized scooter, which would be taken out of the schooling and travel funds.
- My Rheumatologist, Richard L. Stern, MD, thinks that I should use the scooter for the conference. He faxed a letter, stating that is medically necessary for me to use a scooter, for the conference. Here is the copy of the letter from my doctor.
- 2018 TLA conference will be at the Kay Bailey Hutchinson Convention Center is over 2 million square feet.
- I spoke to AABCO-READY RENTAL SALE & REPAIRS, about the cost of the scooter rental. She told me, that it would cost \$203.00 for 3 days rental.


