interested in a contract with the county.

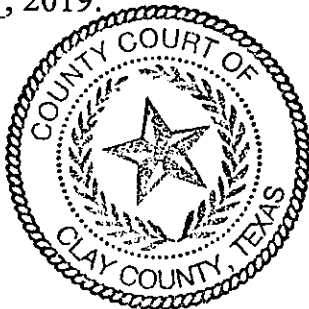



