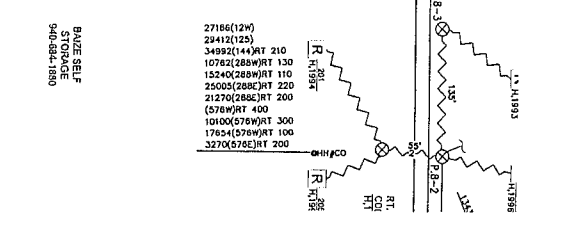
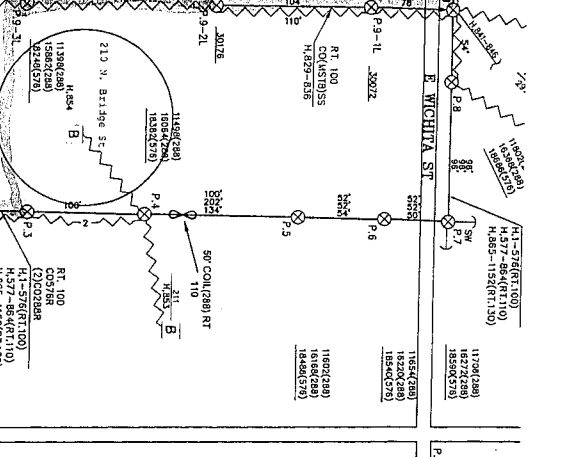
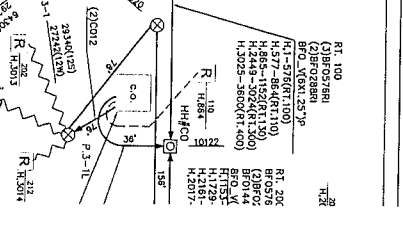
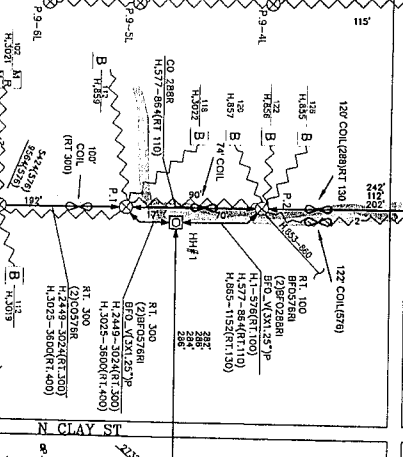
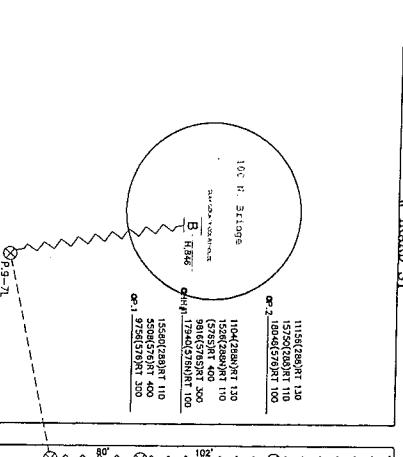
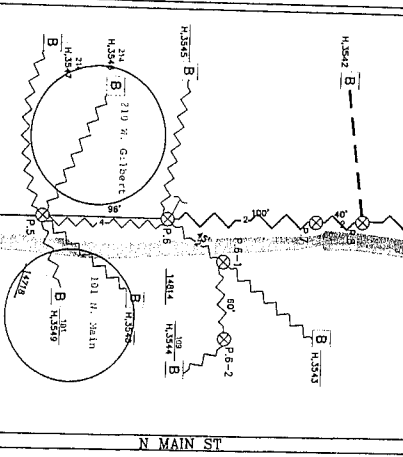
CTC Network Overview
