Dear Judge Campbell and County Commissioners,

I, Norma Ruiz-Hearne, Library Director on behalf of the Edwards Public Library of Clay County, would like to ask permission from the Clay County Judge and Clay County Commissioners to apply for Emergency Connectivity Funds (ECF) for technology equipment and internet access grant and the window to apply is currently open and will expire shortly (August 13),

The ECF is a one-time, \$7.17B funding program, authorized by the American Rescue Plan Act (ARPA) of 2021 providing reimbursement for remote internet access expenses for K-12 schools and public libraries. Libraries serve the community as an objective resource of information and act as a technology gateway to online resources. Aiding to that mission, we have had many great programs with public libraries all over the US as of circulating hotspots and tablets.

We are interested in having hot spots for circulation for Clay County Residents, who are unable to have internet at their homes.

I spoke with Paola Saad Castillo, from T-Mobile and she explained to me how this grant would work, to better serve the residents of Clay County. If the library were to have up to 10 hot spots, the library would be able to loan them to library patrons, who do not have internet at their homes.

- Edwards Public Library patron, who do not have internet access in their home (especially those homes that have students, who need school work don and no internet).
- It would also benefit our own Clay County Offices

- Our Election Administrator to use at all of the polling booths, to keep in network.
- The Clay County Commissioners, would also be able to use the hot spots, when they need internet out at various job sites.
- Clay County residents who have library cards and need an internet hot spot when out in the county (like our local commissioners and local officials)
- These hot spots, would really benefit all residents of Clay County.

I know, that you are wondering about how much it would cost, to get this set up. T-Mobile, would pay \$90.00 for each piece of equipment, the grant if accepted would pay the \$29.05 a month per unit the first year of the grant. After the grant, we can apply for e-rate to pay the \$29.05 per unit monthly cost, because they are now allowing programs to apply e-rate for hot spots, laptops and tablet.

How Can Schools or Libraries Apply?

- The ECF application filing window will open on June 29, 2021 and close on August 13, 2021. During the application filing window, eligible schools, libraries, and consortia of eligible schools and libraries, can submit requests for funding to purchase eligible equipment and services between July 1, 2021 and June 30, 2022.
- The Universal Service Administrative Company (USAC) is the administrator of the ECF Program and will review applications.
- Interested schools and libraries can find more information and apply at emergencyconnectivityfund.org

Q: What will be the duration of internet service reimbursement?

A: Internet service reimbursement will be for services delivered between July 1, 2021 and June 30, 2022. Services delivered after June 30, 2022 will not be covered by the initial filing window.

Q: Will applicants be required to sustain the cost of the internet service until a Wi-Fi hotspot reaches the three-year mark?

A: No. For the initial application filing window, internet service will only be funded by the ECF Program through June 30, 2022, but there is no FCC

requirement that an applicant must provide additional internet service for a hotspot device.

Q: If ECF-supported equipment is considered obsolete after three years, can a school or library repurpose the equipment for solely on-campus usage? A: Yes. Obsolete equipment is covered under section 54.1713(b) of the ECF rules.

Q: Can a school or library keep the money for ECF-supported devices that are sold after the three-year mark?
A: Yes.

Q: How should applicants request funding for equipment associated with a service request (e.g., a \$5 monthly fee for a modem or Wi-Fi hotspot connected to a broadband service)?

A: Applicants should work with their service providers to separate the costs of the equipment from the services and submit them on separate funding requests.

We would really appreciate you approving this grant that will not only benefit the Edwards Public Library, but all of the residents of Clay County.
