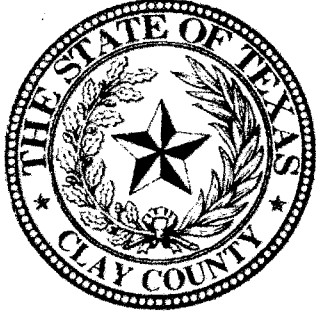

GENERAL CONDITIONS:

- A. Prospective bidders must show the Commissioners' Court that they are qualified, responsible, and capable of fulfilling the conditions.
- B. If the contractor is unable to deliver on request within (8) eight hours' notice, the County reserves the right to purchase on the open market and charge the contractor the difference between the contract price and the purchase price.
- C. The County may grant such relief as appropriate if the contractor is unable to perform due to circumstances beyond his control and not attributable to fault or negligence on part of the contractor. The burden of proof of need for relief rests with the contractor and any request for relief must be presented to the Commissioners' Court in writing.
- D. Freight cost consideration will apply to each bid.
- E. Loading time and weigh out time will be considered on each bid.

Price (s) must not include any federal or state taxes.

BID BASIS:

1. Contractors may bid for any or all items at any or all locations or any combination thereof. The Court reserves the right to select one or several suppliers as determined to be most advantageous for the County.
2. In recognition of market price fluctuations, contractors may increase and decrease the bid price during the contract term based on increased or decreased product cost. However, in event any product cost is increased in excess of 5% over the initial bid price, the County reserves the right to select another supplier if the Court determines the increased price is not competitive with that of other area suppliers. Likewise, if the contractor's initial bid price does not remain competitive because of failure to pass product cost decrease to the County, the Court may select another supplier whose price more adequately reflects market conditions.
3. Prices bid must not include any federal or state taxes.
