Attached is the IGT schedule from HHSC with the IGT amounts due in Column AR of the "CHIRP Payment Calc" tab.

Please note that HHSC's official IGT submission deadline is November 17th. However, to ensure we have all the information needed to complete/submit a separate **MRSA West** region-wide CHIRP SDA Allocation Form before the HHSC deadline, we are requesting that you complete your IGT submission no later than noon on Wed., November 16th. Below are the detailed instructions for completing the IGTs submissions for the CHIRP 2022 IGT. If you have any questions or need assistance, please reach out to one of the MRSA West Region Contacts and we will respond as soon as we can.

The amount that needs to be submitted into TexNet for all entities is in **Column AR** of the "CHIRP Payment Calc" tab.

1. Please enter your IGTs into TexNet no later than noon on Wednesday, November 16th (and specify a settlement date of November 18, 2022).
 - You can enter your IGT into TexNet earlier and the funds will not be drawn down until the settlement date.
 - You must select "CHIRP Amount" in TexNet when you enter your IGT. If you are submitting for more than one facility, you may combine the amounts into one submission.
 - You must save a screen shot/PDF copy of the IGT confirmation/trace sheet before logging out of TexNet.
 - If you are submitting an IGT for multiple hospitals in the same SDA, you may submit one lump sum IGT that covers all the hospitals supported by the IGT.

The IGT amounts can be found in column AR on the "CHIRP Payment Calc" tab of the *Second Half Year 2 Suggested IGT* file. This file has been updated today, November 2, 2022, and can be found under **Suggested IGT – SFY 2023** on [the Provider Finance CHIRP website](#).

- The IGT must be entered into TexNet no later than close of business November 17, 2022 with a settlement date of November 18, 2022.
- This settlement date is non-negotiable.
- The funds need to be placed in the "CHIRP" Bucket.
